CUTS-FAO Joint Validation Workshop

CUTS Nairobi, Kenya in conjunction with Food and Agriculture Organisation (FAO) of the United Nations organised a Study Validation Workshop on 'Trends, Experiences and Socio-Economic Impact of Formalisation of Informal Trade in Africa' with a focus on women small



traders. The aim of the Workshop was to share best practices and lessons from East, West and Southern Africa on how to formalise Informal Cross-Border Trade (ICBT). The workshop had a diverse participation of over 36 participants representing different types of organisations.

Public Hearing: Inter-agency Coordination in Investment

Cuts Lusaka, Zambia along with, Centre for Trade Policy and Development (CTPD) and Caritas Zambia with support from Oxfam Zambia collaborated with the Ministry of Commerce, Trade and Industry to host a meeting on June 13, 2017 at Radisson Blue Hotel, Lusaka with key stakeholders to explore ways on how civil society and government could work together on promoting inter-agency coordination on investment and tax-related issues including the investment database.

Bomet County RE Study Validation Workshop

UTS Nairobi, Kenya held a study Validation Workshop under the Strategic Partnership in Energy (SP-E) programme on May 12, 2017 in Bomet County, Kenya.

The objective of the workshop was to get the inputs and amendments from the county representatives into the draft study report. The study, conducted by CUTS Nairobi focussed on the barriers to uptake of renewable energy (RE) in Bomet County. The forum provided a platform to discuss deeper issues on energy accessibility in Bomet County.

ONGOING PROJECTS

Cross-Border Trading Literature Review

CUTS Accra, Ghana with funding support from the FAO is implementing a project in Ghana called 'Cross-Border Trading Literature Review'. The aim of the project is to document literatures on cross-border trade in Africa, in partnership with CUTS Lusaka, Zambia and CUTS Nairobi, Kenya. The project is being implemented for a year.

Resolving the Unresolved NTBs in the EAC

Resolving the Unresolved Non-Tariff Barriers (NTBs) in the East African Community (EAC), CUTS Nairobi, Kenya has undertaken a Study on 'Resolving the Unresolved NTBs in the East Africa Community'. Under the initiative it has published the third Policy Brief on NTB reporting system in the EAC and an analysis of data collected through additional interviews with truck owners and drivers has been accomplished.

State of the Economy II

The Energy Crisis and the Impact on the Economy

In light of the package that Zambia is currently negotiating with the International Monetary Fund (IMF), CUTS Lusaka, Zambia will be undertaking a study and advocacy measures on the likely impact of the removal of fuel subsidies on consumers. The data was collected by the global market research firm — Ipsos and has been analysed by both CUTS and Zambia Institute for Policy Analysis and Research (ZIPAR). The Paper has been finalised and has been sent out for peer review. A dissemination meeting will be held on July 14, 2017.

Coalition Building on Trade and Economic Regulation Issues

CUTS Nairobi, Kenya is working on 'Capacity Building On Coalition Building on Trade and Economic Regulation Issues in Africa' with the support of Oxfam Novib. So far, invitations have been sent to CSOs to join African Coalition on Trade and Economic Regulation (ACTER) and the ACTER Google group has been established. The final internal draft of the strategic plan has been shared with partners for their inputs and awaiting comments from the partners.

Understanding and Raising Awareness on Healthcare Issues

The objective of the The Competition and Consumer Protection Commission (CCPC) project is to understand the healthcare issues and the regulatory effectiveness of the health system in Zambia.

Leveraging Regional Policy Successes to Improve FRA Interventions

The objective of the project 'Leveraging Regional Policy Successes to Improve Interventions by the Food Reserve Agency (FRA)' is to contribute to the development of a more effective and efficient FRA in Zambia.

Enhancing Investment in Agriculture for Women Smallholder Farmers

The project 'Enhancing Investment in Agriculture for Women Smallholder Farmers and Ensuring Increased Access to Land' has been approved and contract has been signed. Two Position Papers will be drafted and policy engagement meetings will be held with Zambia Development Agency (ZDA) and other relevant institutions.

Meeting with USAID

CUTS Accra, Ghana will be meeting with United States Agency for International Development (USAID) to follow up on the Economic Community of West African States (ECOWAS) study proposal shared with them and other possible project themes.

Meeting with West Africa Trade Hub

CUTS Accra, Ghana will be having a meeting with the West African Trade Hub to further discuss possible collaborations in the region on trade related issues.

Meeting with International Fertilizer Centre

CUTS Accra, Ghana will be meeting the International Fertilizer Centre (IFDC) to discuss possible extension of CREW staple food finding research on issues relating to the fertilizer sector.

Exploring the Anticompetitive Practices in Fertiliser Transportation in Ghana

'Exploring the Anticompetitive Practices in Fertiliser Transportation in Ghana' study was undertaken by CUTS Accra Centre with the aim of exploring possible causes of high prices of subsidised fertilisers in the country. The study was carried out with the sole aim to investigate if any anticompetitive practices are prevailing at the port handling and inland transportation of fertilisers as well as to determine the possible effects of such anticompetitive practices on the retail cost of fertilisers in Ghana. The research study emerged from the project entitled 'Competition Reforms in Key Markets for Enhancing Social and Economic Welfare in Developing Countries (CREW)' project which was implemented in Ghana, India, Philippines and the Zambia, across two common sectors: 1) Staple Food and 2) Bus Transport sectors with the aim to demonstrate the benefits of competition reforms to consumers and producers.

Advancing Competition Regime in Select West African Countries

Cuts Accra, Ghana is seeking funding support to implement a project entitled 'Advancing Competition Regime in Select West African Countries through Capacity Building and Technical Assistance'.

For enhancing the voice of economic justice advocates in the EAC region the project 'Integrating the Voices of Economic Justice Advocates in the EAC Economic Development Agenda through a Right Based Approach (IVORI IV)' is being initiated by CUTS Nairobi. It seeks to identify key issues on economic justice within the EAC region to be addressed, to develop a strong network of economic justice advocates for a harmonised/coherent voice in the EAC Region and develop a Strategic Action Plan for addressing Economic Injustices in the Region.

Better Coordination Delivery and Review of Interventions and Trade Capacity

With the support of Ministry of Commerce, Trade and Industry (MCTI), CUTS Lusaka, Zambia will be implementing the project 'Strengthening the Coordination Delivery and Review of Interventions and Trade Capacity on Environmental and Competition Issues'. After finalising the concept notes, complete proposals will be tabled at the EIF Steering Committee Meeting in the following quarter.

Understanding Low Intra-regional Trade in Food Products

CUTS Accra, Ghana is seeking funding support from USAID and ENDA-CACID to implement a project entitled 'Understanding Low Intra-regional Trade in Food Products in Select Economic Community of West African States (ECOWAS) Countries'. The goal of the project is to enhance food security in select West African countries through the increased intra-regional trade in food in ECOWAS in a sustainable manner.

Realisation of Consumer Rights to Health through Accessible Quality

CUTS Nairobi, Kenya is seeking funding support from Open Society Initiative for Eastern Africa (OSIEA) for the project 'Realisation of Consumer Rights to Health through Accessible Quality Medicine in Kenya'. There is need for Government, non-governmental organisations (NGOs) and mining companies to find ways of ensuring that the Zambian mineral wealth benefits all, CUTS Lusaka (Zambia) Coordinator Chennai Mukumba said. Mukumba said measures must be put in place to ensure that people benefited from the minerals, which were a depleting resource. She said Zambia was rich and endowed with valuable minerals that needed to benefit the communities they were mined from.

"It is the responsibility of the civil society and the Government to ensure the Zambian people benefit from the minerals being mined in the country. Every Zambian deserves to have a share of the national cake either directly or through access to good health, education or infrastructure, constructed from the resources made from the mining sector", she added.
