





India to Boost Bilateral Trade through India-West Africa Regional Conclave

ndian High Commissioner to Nigeria, Nagabhushana Reddy, said that the bilateral trade between India and Nigeria would be strengthened through the India-West Africa Regional Conclave.

Reddy said this during a press conference on the India-West Africa Regional Conclave in Abuja during October 08-09, 2018. The conference was organised by the India High Commission in collaboration with Confederation of Indian Industry (CII), Nigeria Investment Promotion Council (NIPC) and Abuja Chamber of Commerce and Industry (ACCI).

According to the envoy the conclave will serve as platform for dialogue between India and the 15 West African countries. Reddy said: "This is part of our larger engagement to support governments on the provision of business platforms with different stakeholders. It is in this context that the second edition of the regional conclave will hold in Abuja; we are looking forward to government to government level of business engagement. I hope the conclave will draw a new era of engagement between our country and West African countries with Nigeria at the centre. Nigeria is the largest trading partners of India and vice versa the biggest in Africa. So, we are very hopeful these engagements will bring about the much desired promotion in terms of more Indian technology investment, generation of employment, which will benefit India and Africa."



Bilateral trade between India and Nigeria would be strengthened through the India-West Africa Regional Conclave. The conclave will serve as platform for dialogue between India and the 15 West African countries.

The Regional Director of CII, Balakrishan Rajesh, said that the conclave is important for both countries to create platform for business people to meet and interact. He added that Abuja was chosen as a venue because India has identified Nigeria as preferred country for its trade with energy-rich West Africa in line with the country's diversification policy. He also mentioned Cote d' Ivoire and Ghana as other countries in the region that were listed in India's policy of diversifying its energy sources.

According to Rajesh, the conclave is structured into thematic sessions focussed on major areas of India-West Africa economic partnership. "This includes sustainable financing, infrastructure and green energy, agriculture and

agro-processing and services (education, health and IT)," Rajesh said.

Over 200 delegates across 15 African countries, 70 business representative from India and 20 chief executives officers participated in the event.

Adeshina Emmanuel, Director of Investment Promotion of Nigerian Investment Promotion Commission, said that the conclave initiative would be apt for sustainable partnership between India and Nigeria.

According to him, it will encourage private sector operators and key financial institutions to identify priority areas and special projects for Indian investment and partnership with long terms commitment to West Africa.

The Government of India has presented a cheque of US\$1mn to the Ghana-India Kofi Annan Centre of Excellence (GI-KACE) in Information Communication Technology (ICT), to strengthen ICT Research and Innovation in country.

The fund, which is a grant, would support the Centre in capacity building for the expansion needs of ICT research product development and service delivery.

Over the next three years, the grant would be used to develop human resource and state-of-the-art ICT laboratories, a self-sustaining system to take up assignments in technology development, research backed by a self-sustaining business model.

Zambia-India Trade Exceeds

Trade between Zambia and India has exceeded the targeted US\$1bn in the year 2018. According to a statement released to Zambia News and Information Services (ZANIS) by First Secretary for Press and Tourism at the Zambian High Commission in India, Bangwe Naviley, trade between the two countries has improved from US\$650mn in the year 2016 to US\$980mn in 2017 and it has now exceeded the US\$1bn target for the year 2018.

Zambia's High Commissioner to India Judith Kapijimpanga disclosed that the business visas issued to Indian traders and investors also increased from 520 in the year 2017 to 602 in the year 2018, which represents an increase of 82.

India-UAE Ink MoU for Africa

India and UAE for the first time will sign a memorandum of understanding (MoU) to set up projects in third countries beginning with Ethiopia during Foreign Minister Sushma Swaraj's ongoing visit to the Gulf country.

The MoU will focus on third country projects beginning with Africa under the South-South cooperation model. India and UAE

will collaborate to set up an IT excellence Centre in Ethiopia riding on Delhi's expertise and UAE's funds in the Eastern African country.

While Ethiopia is the highest recipient of India's concessional loans outside South Asia, UAE enjoys political goodwill in the country for having mediated between Ethiopia and Eritrea. (ET, 04.12.18)
